LIVESTRONG PROGRAM AT THE YMCA



Cancer takes tremendous physical and emotional toll on those affected and their families. The Y is here to help. LiveStrong at the YMCA is a 12evidenceweek. based physical activity program

with the goal of getting cancer survivors back on their feet at no cost to them. The program includes two sessions per week, which implements a combination of cardiovascular conditioning, strength training, balance and flexibility exercise.

Building supportive and life-long connections with other survivors is at the core of what makes the LiveStrong program so powerful for participants. "Through interaction with staff, volunteers and each other we learned we all have our challenges that can be conquered through sharing and support," states Ruth Johnson, LiveStrong volunteer and participant.

The YMCA was one of the charities selected as a beneficiary of this year's 4C Golf Tournament organized by the Black Diamond Ladies Golf Association. The Black Diamond Ladies Gold Association donated more than \$15,000 to LiveStrong at the YMCA. "Since some of our members are cancer survivors, or are currently fighting this disease, our passion to support LiveStrong is deeply rooted in our charitable efforts to help others move beyond cancer in spirit, mind and body," states Demetria Cefola, 4C 2019 CCCC Co-Chair.
