GROWING OPPORTUNITIES

The Y believes every child deserves the support, guidance and encouragement to be who they are and discover who they can become.



Academic Success is a key focus of the Y's youth development work. To close the achievement gap between children from lower-income households and their middle/upper-income peers, the Y provides guidance, encouragement and support along the learning continuum – from early learning and preschool to high school graduation and college. The Y works with local caregivers, students and schools to offer evidence-based programs that improve students' educational readiness, engagement and outcomes, while helping them grow emotionally and physically, too.

From lakes to pools and rivers, there is water everywhere in the Tampa Bay area and **Water Safety** education is imperative. In Florida, 88 children lost their lives to drowning in 2018. That's up 7 percent from the prior year, according to the Florida Department of Children and Families. This heartbreaking statistic motivates the Y to work hard to ensure every child is safe around water. Thanks to the generosity of the Tampa Bay Rays, Florida Blue Foundation, Juvenile Welfare Board, and United Way Suncoast, the YMCA of the Suncoast is able to offer



Prior to joining the Greater Ridgecrest YMCA, **Michael Robinson** struggled in many aspects of his life, but living without electricity or access to food

were primary problems with ripple effects on the rest of his life. He often did not go to class or complete his assigned work. This resulted in low grades and a lack of self-esteem and confidence. This prevented Michael from maturing into the man he wanted to become. The Y changed everything. "From the moment Mike arrived, the staff wrapped their arms around this kid and were never going to let go," says Executive Director Brad Barnes. "We rooted

for him and loved and supported him as much as we could." As part of the Y family, Michael received healthy meals on a consistent basis. The Bridging The Achievement Gap (BTAG) program provided Mike with tutoring, homework help and career counseling. With the invaluable support from mentors, Michael was able to focus on schoolwork and improve his grades. BTAG opened up other pathways including Job Corps Workforce Training, where he earned a driver's license, his high school diploma and a certification in the electrical trade. "The lessons I learned while attending YMCA programs have helped ensure that I enjoy a bright future," testifies Michael.

Safety Around Water as a free introductory swim program to local children. In a safe, structured environment, Y instructors instill a love of the water while helping kids and parents build safety skills and knowledge.

Many children and families need a second chance. The YMCA of the Suncoast is here for them. When a child or teen is removed from their parents or guardians, they

are placed in foster care if there are no relatives able to care for them. Through **Outreach** work, the Y partners with Eckerd Kids, Directions for Living, Youth and Family Alternatives, Lutheran Family Services, Kid Central and the Pinellas Community Foundation to offer foster care children and teens free access to learn, grow and thrive in our Ys across Pinellas, West Pasco, Hernando and Citrus counties.

As the Pinellas County Schools' Associate Superintendent of Student and Community Support Services, Lori serves as the Y's liaison and partner for our Before & After School Care in Pinellas County. The lifelong educator is always willing and available to help the Y partner with schools, working with principals to continually improve program quality. Lori has the best interests of all youth top of mind while advocating for stronger collaboration between the Y and public schools. Lori plays an integral role in ensuring the Y nurtures the potential of students beyond the classroom.



STRENGTHENING OUR COMMUNITY

The YMCA of the Suncoast improves the community’s health and well-being by providing programs and activities that promote wellness, reduce risk for chronic disease and help others manage and reclaim their health.

In 2018, the Y expanded educational programs to help community members navigate through **Chronic Disease Prevention**. Earning full recognition from the Centers for Disease Control and Prevention (CDC) in 2018, the Y’s Diabetes Prevention Program has been shown to reduce the number of cases of Type 2 diabetes by 58 percent and 71 percent in individuals over age 60.

Study after study shows working out your brain and body will lead to longer and fuller lives. Such research drives many seniors to better their mind, body and spirit through the Y’s **Healthy Aging** programs. From group exercise to yoga, water aerobics and potlucks – active older adults aren’t just receiving physical benefits – they’re building relationships while increasing their self-confidence and sense of achievement.

A cancer or arthritis diagnosis can happen to anyone, even those who live the healthiest lifestyles. The



JaneAnne Dampier first joined the James P. Gills YMCA after several months of physical therapy following a car accident. She started by

exercising in the heated pool but after undergoing four open spinal surgeries – coupled with long, difficult recoveries and mounting medical bills – JaneAnne discovered the Y as her place to heal. It’s a place to regain her health through

symptoms and treatment of such life-changing diseases can take a tremendous physical and emotional toll. The Y offers evidence-based programs to help adults **Reclaim Health**. **LIVESTRONG®** at the YMCA helps adult cancer survivors build muscle mass and strength; increase flexibility and endurance; and improve confidence and self-esteem. In addition to physical benefits, the program focuses on the emotional well-being of survivors and their families by

Enhanced®Fitness, yoga, tai chi and wellness equipment. As a mother to three active daughters, JaneAnne also appreciates the scholarships the Y provided for her family over the past two decades. As she continues down her road to recovery, JaneAnne especially loves the welcoming support and positive encouragement she receives each and every day at the Y. “The YMCA has been a blessing and a big part of life for me and my daughters,” exclaims JaneAnne.

providing a supportive community where individuals affected by cancer can connect during treatment and beyond. Likewise, Enhance®Fitness has been proven to improve quality of life for those with arthritis. Through low impact exercise, participants become more active, energized and empowered for independent living. In addition to helping reduce arthritis symptoms, Enhance®Fitness is designated by the CDC as a Falls Prevention Program.



BY THE NUMBERS

The Y's meaningful work is possible thanks to a strong financial foundation. The following summary shows our financial stability and growth in 2018.

- ▲ Membership fees increased more than \$800,000 with the Citrus Memorial Health Foundation YMCA operating for a full year, compared to eight months in 2016. Also, revenue increased in Pinellas County and Pasco County branches, ranging from 4–7%.
- Child care and camp fees increased from a combination of growth in school-age care attendance and additional weeks of summer camp. In 2017, there were three additional weeks of summer camp and three fewer weeks of school-age programs. A longer summer benefits summer camp income in our branches. A reduction in number of weeks of after-school programming normally would reduce annual revenue, but added growth in numbers compensated for fewer weeks.
- ▼ Capital contributions in 2017 relate to Citrus projects, both for the completed facility and for future projects. The decrease is due to reaching fund-raising goals for the initial construction of the Citrus Memorial Health Foundation YMCA while having a less active campaign for future capital projects.
- ◆ Other contributions includes those for the annual fund-raising campaign, for specific programs, special events and for the endowment fund. The endowment fund was beneficiary to less in donations compared to 2016. Annual campaign contributions increased slightly.
- Other revenue includes returns on investments, which experienced larger market value gains compared to 2016. Other miscellaneous income was consistent.
